ADMISSION REQUIREMENTS AND CHECKLIST FOR APPLICATION TO THE PTA ROGRAM: Applicants must meet with an admissions representative before starting any of the application process.

- Application submitted directly to the address listed above (this form).
- Applicants must be at least 18 years of age by the start of the program.
- Wonderlic Assessment completed within one year of application deadline and submitted to WTC through your admissions representative. A minimum score of 20 is required in order to be eligible.
- Official high school transcript or GED demonstrating a minimum of 2.75 GPA or the equivalent score on the GED (minimum score 500). (You do not have to submit your high school transcripts for application if you are submitting your college transcripts.)
- Official transcript from each college attended, if you have attended college, demonstrating a minimum of 2.75 GPA (14 credit hours completed to qualify GPA). Only transcripts submitted by the application deadline will be considered for course credit. Additional updated transcripts may be submitted if courses are noted to be "in progress" during the application process. Please note: Official transcripts must be submitted DIRECTLY from the education institution to the address above. Transcripts submitted from an applicant (even if they are "official") will not be accepted.
 College transfer credit. Applicants who wish to have their previous education considered for credit must do so prior to being accepted and prior to starting the PTA Program. Students who took general education course work over the last ten (10) years, may be given credit provided that the grade(s) earned are a "B" or higher and the course objectives matches what is required for the PTA program general education courses. No credit will be granted for core PTA courses.
- □ Volunteer/Observation Experience Forms submitted to the PTA Program (address above).
- Two letters of recommendation mailed directly to the PTA Program (address above). Note: The person writing the letter should mail this to us. The letters should be from an appropriate sourse; i.e. employeer, teacher, mentors. Not acceptable are family members, friends. A minimum of one letter of recommendation from a clinical practitioner is required.
- □ Submit a copy of your receipt of payment to *Western Technical College*. This is a non-refundable *application* fee of \$25.00. Your admissions representative can direct you the Student Accounts office for payment. DO NOT SEND ACTUAL PAYMENT with your application as it will not be accepted.

ADMISSION PROCEDURES:

- 1.) Complete the "Application for Admission" form (this form) and all of the noted requirements.
- 2.) Applicants that meet the requirements will be invited for a panel interview.
- 3.) Students will be admitted into the PT A program based on a point system that accounts for the application, education,
- GPA, panel interview, Wonderlic test scores and letters of recommendation.
- 4.) A maximum of 24 students will be chosen for admission into the cohort. Several alternates may be chosen in the event that accepted students deny their position or did not complete the requested requirements on time.

The due date for the above requirements is **February 9, 2024**. Incomplete and/or late applications (postmarked or delivered) after the deadline date must reapply for the next application cycle. The start date for this application in June 3, 2024, the anticipated matriculation date for the class which you are applying is February 18, 2026.

ACCEPTED students will be required to complete the following PRIOR TO THE START OF CLASSES:

- •An up-to-date immunization record(s)
- •Initiate the Hepatitis B vaccine or sign the declination form

•An acceptable criminal background check completed (at the student's expense)

° Completion of the WTSI assessment (for the Western Tech Success Initiative program) after acceptance into the PTA program. This examination does not affect the chances of a prospective student entering the program.

ADDITIONAL REQUIREMENTS AFTER ADMISSION INTO THE PROGRAM:

- A standard registration fee of \$100.00 is to be paid to Western Technical College
- Maintain a minimum GPA of 2.75 in each phase. Failure to do so may result in expulsion from the program.
- Physical examination by a physician / practitioner
- You must be physically, emotionally and mentally capable of completing the program
- A felony/positive background check may preclude your ability to complete clinical affiliations and can result in expulsion from the program and/or preclude your ability to take the PTA licensure examination
- Maintain an up-to-date immunization record (including TB test results annually)
- Maintain an up-to-date CPR certification
- Additional requirements of the Clinical Affiliates may be requested and may include: an additional acceptable criminal background check, Hepatitis B vaccine or the declination of the vaccine (written form) and drug testing.
- Some hospitals and health care facilities may have additional requirements such as a current health insurance policy and immunization titers, and Flu shot.

ACCEPTANCE INTO THE PTA PROGRAM

The PTA program application is a competitive process, and the application does not guarantee admission into the program. Acceptance into the PTA program will be based on several criteria and ultimately on the score that will be determined based on your overall application "packet" (all of the components of your application). Each component of the application "packet" is ranked and the cumulative highest scores will be offered a seat in the program (up to the maximum number of seats available) if all of the criteria are met and have no extenuating circumstances that may preclude them from acceptance (see the WTC catalog for "Technical Standards" for the PTA program).

Cumulative points, or overall scores, for each application are confidential and are not shared with ANY applicants or WTC personnel, even after an applicant is accepted into the program. This information is only made apparent to the PTA selection committee or by our accrediting bodies upon request. The following is a breakdown of the components that each applicant will be scored on:

- Educational Credentials may be based on GED, high school diploma, certificates earned, college degree/s or college credits earned, etc.
- **GPA/GED scores** may be calculated from your GED, high school diploma, college credits (you must have at least 14 college credit hours in order to count towards your GPA score).
- Wonderlic Assessment Taken within one year of application deadline.
- **Observation/Experience Hours** (see the "Volunteer/Observation Experience From" for more details)
- **On-site Written Essay** by invitation only for those prospective students that have met the minimum requirements and deadlines for application. It will be completed during the on-site panel interview.
- **Panel Interview** by invitation only for those prospective students that have met the minimum requirements and deadlines for application.

February26, 2024	Email sent out from WTC PTA Program inviting qualified applicants for interview. You should receive your email several days after this date.
March 25-March 29, 2024	Panel Interviews conducted for qualifying individuals. Depending on number of applicants this may extend into following week.
April 8, 2024	Email sent out from WTC PTA Program to applicants as "accepted", denied" or "alternate" (if you receive an "alternate" status, the letter will describe what this status means).
April 15, 2024	Deadline for an email from each applicant to "accept" or "deny" their position in the program to the PTA Program Director if you are accepted into the program or if you are an "alternate". More specific directions will be listed on the letter sent to you. If you do not get a response within one week, please email sn'olan@westerntech.edu. If your email is not received by the deadline, it is assumed that you wish to not accept your position in the program.
May 17, 2024	Deadline for all additional materials (physical, immunizations, WTSI examination, etc.). You will be given additional instructions if you are accepted into the program. Your acceptance into the PTA Program is pending completion of these items.
May 31, June 1-2, 2024	Mandatory orientation dates (you must attend both days): Specific times and places to be determined. (This is a tentative date)
June3, 2024	Anticipated start date for the PT A class
